PRESS RELEASE

Recruitment to the posts of SCT Sub Inspectors of Police (Civil) (Men & Women), SCT Reserve Sub Inspectors of Police (AR) (Men & Women), SCT Reserve Sub Inspectors of Police (APSP) (Men) in Police Department and Deputy Jailors (Men) & Deputy Jailors (Women) in Prisons & Correctional Services Department and Station Fire Officers (Men) in A.P. Fire & Emergency Services Department was notified vide Notification Rc.No.216/R&T/Rect.1/2018, dt: 01-11-2018.

2. Preliminary Written Test (Qualifying) for the above posts was conducted on 16-12-2018 at 7 Locations in 240 Centres in Andhra Pradesh. **1,22,160** candidates participated in the exam out of which **51,926** qualified. The result is available on the website "slprb.ap.gov.in". The breakup of candidates who appeared and qualified, gender-wise, caste-wise and Regional centre wise is furnished below:-

3. All the candidates are once again informed that the qualifying marks are as follows:

OC: 40% in each paper (i.e., Paper-I - 40 Marks out of 100;
Paper-II - 40 Marks out of 100).

BC: 35% in each paper (i.e., Paper-I - 35 Marks out of 100,
Paper-II – 35 Marks out of 100) and,

SC, ST and Ex-Servicemen: 30% (i.e. Paper-I -30 Marks out of 100,
Paper-II - 30 Marks out of 100).

The result for Preliminary Written Test has been prepared accordingly. It is observed that some candidates have mentioned different community in application form and OMR Sheet. The benefit of doubt is given to the candidates in all such cases in preparing the result. However, this result will be subject to the actual community certificate produced by the candidate at the time of PMT/PET.

4. With regard to the answer key released on 17.12.2018 after the examination, more than 300 objections were received. The subject experts looked into all these objections. In respect of the following 3 questions in Paper-I, all the candidates who either answered or didn't answer, were given 1 mark each, in order to extend the benefit of doubt to the candidates. In respect of Paper-II, there are no changes in Preliminary Key. As it is only a qualifying examination and the marks secured therein by the candidates do not have any impact on their Final Merit, no candidate is affected adversely.

5. The Scanned OMR Sheets will be available for download for **three** days from 27.12.2018 afternoon. Any candidate who desires his OMR Sheet to be "verified" may apply online by downloading his scanned OMR Sheet and making payment of Rs.1,000/- (Rupees one thousand only) for each paper through online and submit his request for "verification" on website "slprb.ap.gov.in" from 28.12.2018 (11 AM) to 30.12.2018 (5 PM) in the following format:

6. It is reiterated that the candidate should submit his requests for verification separately for each paper and **not** through one common payment combining two or more requests. Otherwise, first request alone will be considered and others will be summarily rejected.

7. Each valid representation received with fee for each paper separately will only be examined and the decision of the committee in the matter shall be final. No further communication or Anonymous/Incomplete representations will be entertained after the last date.

8. Physical Measurement Test/Physical Efficiency Test for these posts are likely to start on 18-01-2019 at 4 places (i.e. Visakhapatnam, Eluru, Guntur and Kurnool).
