Please superscribe the cover containing the hard copy of internal marks as B.Pharm/III-II/IM/R19/April/May 2025 Exams/<College Code>.

To conduct regular & supplementary laboratory examinations from **21.04.2025 to 26.04.2025** and send the award lists in sealed covers to the address mentioned above on or before **01.05.2025 (Thursday)** without fail by registered/speed post. The cover may be superscribed as B.Pharm /III-I/III-II/R19/R15/Reg&Supple/April/May-2025/Lab Award Lists/<College Code>
3. Complete the first entry of lab externals in EMS by **28.04.2025**.
4. You are requested to finalize the attendance particulars of the students for regular examinations and to upload the detained list to the examinations portal 'JNTUA EMS' on or before 05:30 PM of **21.04.2025 (Monday)** without fail.


